2. **Vacations & Holidays** article pertaining to Snow days on December 5 & 6, follow-up to share, article 5 c

The University closed at midday and a notice was sent to staff; those who could work from home should do so. A Member had a question regarding the Vacation & Holidays article in the Collective Agreement, which states:

c) any other day on which the University premises are declared closed by the President of the University.

5.1 If a Member is required to work on a holiday, as defined in Clause 5 above, they may take one and one-half (1.5) days of additional paid leave at a time agreed upon by the Member and the Employer.

Faculty Relations has stated that December 5 & 6 were not holidays. Clause c) may not be relevant as the University's <u>weather website</u> states: "When a weather threat is identified, a leadership group comprised of the vice-president (Operations and Finance); associate vice-president (Human Resources); director (Campus Community Police Service); associate vice-president (Facilities Management); manager (Landscape Services); and director (News, Media and Community Relations), in collaboration with the provost and vice-president (Academic), gather to examine both the on-the-ground condition of campus and the current/forecasted weather conditions."
